General website

The following data are generally processed and stored on the website:

- age group;
- sex;
- interests;
- language;
- location.

These data are processed to allow us to keep statistics relating to website users. We use these statistics to improve our products and services, as well as to ensure our website functions as efficiently as possible and to optimize the user experience.

Cookies and similar technologies

We use functional and analytical cookies. Functional cookies are needed to ensure the website functions efficiently. These cookies are placed on your computer as standard and cannot be blocked.

Analytical cookies are cookies that help us measure visits to the website. These statistics give us an insight into how often our website and its pages are visited and what information visitors are looking for. With the help of this information we can keep improving the service we provide. The data we collect via these cookies are anonymous and cannot be traced back to individuals. We also use Google Analytics to help us analyze these data efficiently.

Services

If you use services offered by our website, personal data will be stored if you fill in the contact form.

We collect the following data to enable you to use the services referred to above: name, emailaddress, IP address. We may contact you for commercial purposes.

Transfer to third parties

We explicitly undertake not to transfer your data to third parties.

On our website you will find social media buttons. If you use these buttons, the administrators of these services will collect your personal data. Data are also stored via Google Analytics. We use these data to keep statistics and are also able to view individual data. However, we will only do this to the extent necessary for the purposes described in this policy.

Third-party websites

How long we store data for

We store your data for as long as necessary to provide services and for the duration of the warranty periods that apply to our products. We also comply with statutory retention periods.

Inspecting, changing or deleting data

You have the right to inspect the data we hold about you. If certain details are incorrect, you are entitled to ask us to correct or delete them. In some cases we may be unable to comply (fully) with a request (if inspecting your data would infringe the privacy of others, for example). You are also entitled to withdraw any consent you have given regarding the processing of your data or to object to the processing of your personal data by Amsterdam à la Carte.
